BLOODBORNE PATHOGENS (FOR HEALTHCARE)

DOT: REGULATED MEDICAL WASTE

Information on bloodborne pathogens and diseases, methods used to control occupational exposure, hepatitis B vaccine, and medical evaluations and post-exposure follow-up procedures.

Duration & Frequency

45 min. Required to be taken annually.

Staff required to complete this program

All personnel who come into contact with potentially infectious material.

Hazmat Training required for waste handlers packaging, handling, shipping, or signing hazmat shipping papers. You need this training to sign off on a waste manifest!

Duration & Frequency

2 hours. Recommended to be taken every 3 years.

Staff required to complete this program

Required to be taken by anyone handling waste packaging, shipping, or signing of hazmat papers.

HIPAA, HITECH & OMNIBUS

Helps employees understand the new requirements on patient privacy and security.

Duration & Frequency

1 hour, 10 min. Required within 10 days of initial hire, and recommended to be taken annually.

Staff recommended to complete this program All healthcare personnel





Additional Programs



GHS HAZCOM

Covers the revised OSHA standard requiring the use of new GHS labeling and a standardized format for Safety Data Sheets (SDSs), formerly known as, Material Safety Data Sheets (MSDSs).

Duration & Frequency : 1 hour. Required at initial hire, and recommended to be taken annually or when a new physical or health hazard is introduced.

Staff recommended to complete this program : All employees who are exposed.



HAND HYGIENE FOR HEALTHCARE

This training helps employees understand the importance of proper hand hygiene, and provides guidance on which hand hygiene protocol is best for their work environment.

Duration & Frequency : 20 minutes. We recommend this course be taken annually. **Staff recommended to complete this program :** All healthcare personnel.



FIRE SAFETY

Fire safety training looks at how fires start, reviews steps that can be taken to help prevent fires and outlines what employees should do in case of a fire emergency.

Duration & Frequency : 30 minutes. We recommend this course be taken annually. **Staff recommended to complete this program :** All healthcare personnel at initial hire.



ELECTRICAL SAFETY

This training outlines electrical safety requirements in healthcare settings and walks through what checks should be done and actions carried out to ensure the safety of employees.

Duration & Frequency : 30 minutes. We recommend this course be taken annually. **Staff recommended to complete this program :** All healthcare personnel.



▶ PPE

Training on how to properly use and dispose of personal protective equipment.

Duration & Frequency : Approximately 25 minutes. We recommend this course be taken at orientation and as needed. **Staff recommended to complete this program :** All healthcare personnel.



SHARPS SAFETY

This training covers the nature of sharps injuries, the risks of exposure to bloodborne pathogens, how and where injuries occur, describes the types of engineered sharps injury prevention devices, and discusses safe work practices to prevent sharps injuries.

Duration & Frequency : 19 minutes. We recommend this course be taken annually. **Staff recommended to complete this program :** Healthcare personnel taking BBP.
